Message from the Chairman

As the Kosciuszko Foundation continues to grow and expand in its 94th year, the brilliance of our founder's vision, to encourage intellectual, artistic and cultural growth among Poles and Polish-Americans, becomes more evident every year.

Stephen Mizwa was often criticized during his life. When scholarships and grants are awarded based on merit, hard work and grades, there will always be joy for those who receive them, but disappointment for those who must try, try, and apply again.

But ultimately hard work pays off, and the success of Kosciuszko Foundation alumni is legendary. Over the years, the Foundation has awarded tens of millions of dollars to scholars and artists.

We can't do any of this without your donations and dues to keep that mission going. And we can promise you that the recipients of our grants will always be those with the most academic merit from the pool of applicants.

In the current review and digitalization of our archives, true gems pop up from time to time: like an original letter signed by Tadeusz Kosciuszko; a letter to the KF from Maria Sklodowska Curie (Madam Curie), photos of Ignacy Paderewski at the first ball, and notes from the 1976 visit by Cardinal Karol Wojtyla (later Pope John Paul II) who said the Foundation's work is "particularly important."

One of the new discoveries from the archives is a letter written by Stephen Mizwa to one of his detractors, a concerned "Citizen" who was denouncing a professor that the Foundation brought from Poland for being radical and not a proper Catholic.

In defense of that professor, Mizwa responded, "You can criticize the Foundation because we are a public institution, regardless of whether you are correct or not... I believe in tolerance."

More importantly, Mizwa stated the Foundation's stands on politics and religion: "Dear Citizen, some accuse the Foundation of not being Catholic, only radical; others accuse it of being too pro-Catholic. But the Foundation is not left wing, right wing, pro-religion, or anti-religion. The Kosciuszko Foundation is only pro-Polish and does good work for Poland. We bring from Poland professors who speak English well, and we don't ask about their social or religious views."

And here's the surprise.

The Professor being attacked by the Citizen, and defended by Mizwa, was the famed Oscar Halecki, the famous historian, social and Catholic



activist, who served as a member of the Polish delegation at the Paris Peace Conference that helped Poland to restore its independence after World War I.

After Germany invaded Poland in 1939, Halecki taught at the Sorbonne in Paris, and was later a professor in America at Vassar, Fordham and Columbia University. He was an outspoken critic of Communism.

Each year, the Polish American Historical Association awards the coveted Halecki Prize, of which I am an appreciative recipient for my biography of Kosciuszko.

The intellectually honest Mizwa wrote to the citizen that he will defend his right to free speech, but that he was not correct in his attack on the famed professor because "Prof. Halecki is an excellent historian and is doing incredible work for Poland at prestigious American universities."

We are proud of our legacy and grants to scholars like Prof. Halecki, and the Kosciuszko Foundation makes new history every day. Recently, Andrzej Duda became the first sitting President of Poland to visit the Foundation.

It was not a meeting about politics or religion.

President Duda came to meet with the members of the KF Collegium of Eminent Scientists, which showcases the work, research and technological advancements of Polish scientists. The collegium includes Polish Nobel Prize winners. Several of them are working to cure cancer and other diseases.

So just as Stephen Mizwa defended the Citizen's right to free speech and tolerance, we will continue that legacy, and always work to use merit and academic integrity as our guiding principle in promoting the intellectual, artistic and cultural growth of Poland and Polish Americans.



In Service of Poland and Polonia

Two visions – two projects and cooperation for almost a century

typewriter or desk space, and no funds. There was only a dream and a few people who believed in it". In such words, after World War II, Stephen Mizwa, creator and founder of the Kosciuszko Foundation, described the first days of the work to which he devoted his entire life. These words, properly paraphrased, can be related to Poland's situation in 1914 – nobody believed in its success, thinking that Poland was an internal problem of Russia, Germany and Austria-Hungary. Like the astonishing phenomenon of Poland regaining its statehood in 1918, the remarkable success of Mizwa was unprecedented at the time. He managed to gather around him people of science, culture and business who were not only visionaries, but who also had the desire and ability to put their ideas into action.

The beginnings of realizing the vision

The Kosciuszko Foundation, established in 1925 to commemorate the 150th anniversary of Tadeusz Kosciuszko's arrival in America and his joining the struggle for American independence, was intended from the very beginning to connect two countries – Poland and the United States of America.

The Foundation was to act as an intermediary between the two countries, by creating opportunities for Poles and Americans to gain a deeper understanding of one another. It was a complete novelty, and not only in the Polish community abroad. The Enlightenment models were drawn on — due to the lack of funds, it was decided to bet on the best, i.e. the elite of both nations. A scholarship program was created to enable American scholars, scientists and students to come to Poland on a long-term basis,

and Poles to study and become acquainted with the educational system in the USA. During the short period before the outbreak of World War II, over one hundred people participated in the scholarship program – the scale and range of the Foundation's activities were unrivaled at the time; citizens of no other Eastern European country had such opportunities to learn about the USA. No other country in Eastern Europe was visited by such a great number of Americans as Poland. The Foundation promoted unparalleled forms of patriotism: promoting the best, improving professionalism, involvement in building a civil society, loyalty to both countries and searching for threads of mutual connections.

First challenges and successes

The Foundation cooperated with professionals from both countries to rectify erroneous opinions about Poland in the USA. It also promoted a positive image of Poland based on reliable and verified information rather than information based on propaganda.

In 1929, two of the first scholarship holders, Eric P. Kelly and William J. Rose, were resolving insulting opinions about Poland propagated at American universities by the famous British philosopher, logician and mathematician Bertrand Russell.

Thoughtful and caring governmental support from both countries and from business owners, careful selection of scholarship holders (many who were successful in public life) and Mizwa's extensive connections at American universities were not in vain. By 1927, he came up with an idea to create a million-dollar endowment fund for the Kosciuszko Foundation: two-thirds were to be given by the Americans, and one-third by the Polish community abroad. A star of the American cinema,

Gilda Gray (born Marianna Michalska) became personally involved to help. In 1928, the Foundation organized another USA concert tour of the second prime minister of reborn Poland and the great pianist, Ignacy Jan Paderewski. As an expression of his gratitude, the master, treated as one of the symbols of Polish-American friendship, donated a large part of his earnings to the Foundation.

Revision of plans

Unfortunately, the crisis of 1929 shattered Mizwa's big plans. This does not mean, however, that he did not undertake other tasks. At the beginning of the 1930s, the Foundation co-organized summer schools in Poland of Polish culture and language for Americans, raised funds for the construction of dorms in Krakow and Warsaw, and organized an initiative that is a flagship of the Foundation today — annual balls.

During World War II, the Foundation made a huge contribution to the fight for Polish independence by saving Polish scholars, scientists and artists from occupied Europe and creating new working conditions for them in the USA. Such scholars and scientists as Oskar Halecki, Aleksander Turyn, Antoni Zygmund, Wacław Lednicki, Wojciech Świętosławski, Rafał Taubenschlag and Jan Kucharzewski found a safe haven and opportunity to continue their research at American universities. In 1943, great celebrations were organized during which the mathematician and astronomer Nicolaus Copernicus was promoted in the USA as a Polish

scholar and not a German one, as intended by the propaganda of Nazi Germany. Albert Einstein, himself, supported Mizwa in these efforts.

A new start in difficult realities

The legacy of Mizwa is openness to new forms of Polish-American cooperation, depending on the needs and changing realities. Mizwa knew that governments and times would change, but investments in bringing new generations of Poles and Americans closer together would allow the continuation of the Foundation's mission. Mizwa believed that the forms of the state may change, but the Polish nation would remain the same. Thus, Polish patriots in the USA were to support their compatriots in Poland, regardless of the changing political realities. Therefore, after 1945, despite the Cold War and the negative image of the United States in the Eastern Bloc countries, the Foundation resumed its work. It continued the scholarship program and joined the initiative of sending thousands of books to destroyed Polish academic libraries. In these difficult years, thanks to the support of the Foundation, such luminaries of Polish science as Jacek Woźniakowski, Przemysław Mroczkowski and Alfred Reszkiewicz conducted their research in America.

Meeting new needs

When, in the 1970s, after the death of Mizwa, a new generation of leaders took over the management of the Foundation, it was given

new energy. Long-lasting cooperation with the Jagiellonian University was renewed and summer courses of Polish history and culture began to be organized in Krakow. The Foundation managed to bring the famous art historian, prof. Karol Estreicher, to the USA. His lectures were organized at many American universities. Work on an impressive Polish-English dictionary, adapted to new needs and challenges, was another significant project. It was thanks to the Foundation's money that Roman Maciejewski's famous Requiem — a tribute to the victims of World War II — had its premiere in the USA, and the composer Henryk Mikołaj Górecki, widely fêted in the USA, could finish works for the famous Kronos Quartet. Support for interned Solidarity activists, many of whom eventually found themselves in the USA, or material support for Poles at the turn of the 1970s and 1980s, were other initiatives of the Foundation.

The Foundation today

After 1989, a breakthrough year for Europe, the Foundation was recognizable in Poland and America, not only thanks to its extensive scholarship programs, but also to annual English language schools organized in various places in Poland for children and youth. Thanks to cyclical piano and vocal competitions, the Foundation promotes not only the traditions of Polish music, but also young talent many of whom are prominent celebrities today in the circles of worldwide music culture such as the world-famous pianist and conductor Murray Perahia. Thanks to the involvement of President Alex Storożyński, the Foundation was one of the first to actively join the campaign against using the term


"Polish concentration camps," thus returning to the roots of its existence, i.e. fighting for the good name of Poland in the Anglo-Saxon world. Of course, the Foundation is not just about huge projects. Supporting individual scholar and scientist's research, book publishing, lectures in various fields, concerts and cultural events are the Foundation's daily activities. Thanks to them, the Foundation is still a living center of Polish-American life — not only in New York, but also in many other places in the USA and in Poland, i.e. wherever there are local branches and people fulfilling the Foundation's mission in local conditions.

As Poland has changed over the last hundred years, the Kosciuszko Foundation has also been meeting the new expectations and the new challenges of the changing reality for almost as long. That being said, this is one of the best forms of work that Poland can count on in the USA.

The Kosciuszko Foundation Medal of Recognition



In 1955 the Kosciuszko Foundation initiated an award meant to honor special friends od the Foundation who have significantly contributed to our mission of promoting cultural and intellectual exchanges between Poland and the United States.

Called the Kosciuszko Foundation Medal of Recognition, the bronze medal was designed in 1955 by the Polish sculptor Tadeusz Sowinski. It features a bas relief bust portrait of Tadeusz Kosciuszko dressed as an American military hero with the distinguished Order of the Cincinnati pinned to his chest. Encircling the portrait are the famous words of Thomas Jefferson: "He was as pure a son of liberty as I have ever known." On the reverse of the medal, bordered by the lamp of knowledge and wheat of internal inspiration we find the text: "The Kosciuszko Foundation Medal of Recognition for Distinguished Service to Polish and American Culture."

Generally awarded during the Foundation's Annual Fundraising Dinner and Ball, it is not awarded annually. The first award was made to Henry Noble MacCracken for his efforts in establishing the Kosciuszko Foundation. Some others who have received the award were Eric P. Kelly, Artur Rubenstein, Oscar Halecki, Waclaw Lednicki, Kazimierz Wierzynski, Lawrence L. Thomas and Francis J. Whitfield, the editors of the first Kosciuszko Foundation Dictionary, Leopold Stokowski, Maria Kuncewicz, Arthur and Marion Coleman, Robert Goldstand, Zbigniew Brzezinski, Jerzy Kozminski, Archbishop Wesoly, Edward Pinkowski, Ryszard Kapuscinski, Marta Eggerth, President Lech Walesa, Rafal Olbinski, Coach Mike Krzezewski, Professor Frank Wilczek, Wojciech Inglot, Justyna Kowalczyk, Juliusz Machulski and Martha Stewart.

The 2018 Kosciuszko Foundation Medal of Recognition has been awarded to Stanley G. Wojcicki Professor Emeritus of Physics and former chair of the Physics Department at Stanford University in California.

In 2010, he retired following a distinguished 44-year teaching and research career in the Department of Physics. Professor Wojcicki's work at the forefront of experimental particle physics has contributed to a deeper understanding of the evolution and structure of the universe.

For the last 15 years of his career, Professor Wojcicki has focused on understanding the properties of subatomic particles called neutrinos. Despite their huge numbers, neutrinos are difficult to detect because they rarely interact with other particles they can pass through Earth as if it were an empty space. Neutrinos have no electric charge, and they are much smaller than other subatomic particles such as the electron.

They are important because they play a key role in the reactions that power the sun and the stars.

Wojcicki was the founder and original spokesperson for the international consortium known as MINOS (Main Injector Neutrino Oscillation Search). Professor Wojcicki has studied how invisible neutrinos oscillate or switch from one type or 'flavor' to another as they zip around the universe. In the MINOS experiment, trillions of neutrinos produced at the Fermi National Accelerator Laboratory (Fermilab) near Chicago are shot in a former iron mine.

A native of Poland, Professor Wojcicki fled his homeland in 1949. He went on to earn a bachelor's degree at Harvard in 1957 and a doctorate at the University of California at Berkley in 1961. Before joining Stanford, he held positions at Lawrence Radiation Laboratory in Berkley and at CERN in Geneva, Switzerland. During his long career, he was a regular visiting scientist at Fermilab and served as an advisor to several agencies and laboratories in the United States and abroad. At Stanford,

he chaired the Department of Physic twice. A dedicated teacher, he inspired thousands of students to be passionate about science.

Professor Wojcicki has received many honors, including being elected a Fellow of the American Physical Society on 1971 and receiving the Dean's Distinguished Teaching Award in 1979. Most recently, he was awarded the 2011 Pontecorvo Prize for his "outstanding contribution to research on neutrinos" and the 2015 W.K.H. Panofsky Prize for "experiments probing the flavor structure of quarks and leptons." In 2014 he was elected Foreign Member of the Polish Academy of Arts and Sciences.

Stanley Wojcicki is the husband of fellow educator Esther Wojcicki, whom he met at UC Berkeley. They have three children and seven grandchildren. Susan Wojcicki, CEO of YouTube, Google's first office was started in her home. Janet Wojcicki, Anne Wojcicki, founder of the genetic testing company 23andMe. In 2010, his daughter Susan and her then-husband, Google co-founder Sergey Brin, endowed a \$2.5 million chair in experimental physics at Stanford in her father's name.

U.S. Embassy and Kosciuszko Foundation Announce New Exchange Award to Celebrate Polish-U.S. History

n May 17, 2018 U.S. Ambassador to Poland Paul Jones hosted a reception at his residence in Warsaw to honor the work of the New York-based Kosciuszko Foundation in promoting closer ties between the United States and Poland. Together with Marek Skulimowski, the President and Executive Director of the Kosciuszko Foundation, Ambassador Jones personally recognized the 40 new Kosciuszko Foundation Fellows recently selected to pursue research in the United States during the 2018-19 academic year. Those Fellows will conduct research for 3-6 months in the sciences, humanities, arts, and Polish studies. Hailing from all over Poland, the scholars will conduct their research with partner institutions across the United States, including – but not limited to – Stanford University, the University of Virginia, Yale, Hunter College, the University of Texas, Princeton, St. Joseph's University, and the University of California at Davis. Addressing the newly selected grantees, Ambassador Jones called their "breadth of knowledge and expertise inspiring."

During the reception, Ambassador Jones and Marek Skulimowski also announced a "Centennial Award" in honor of the centennial of

the establishment of diplomatic relations between Poland and the United States in 1919. This new exchange grant from the Kosciuszko Foundation – to be generously funded by the Polish company "Collegia" – will be offered during the 2019-20 application cycle to a committed researcher who is eager to enrich and share their expertise in the field of Polish-U.S. relations over the last century. The best candidates for "Centennial Award" will be scientists and Ph.D. candidates researching important moments of Polish-U.S. history after Poland regained its independence in 1918. Their research will be presented for publication after its completion and presented to audiences in Poland and/or the United States in order to increase mutual understanding of Poland and America's shared history. The announcement of the new award will be included in the annual call for nominations of the Kosciuszko Foundation this fall. Ambassador Jones thanked Marek Skulimowski and the Kosciuszko Foundation board members for offering this new award, remarking that "Your work, your energy, and your commitment to promoting closer people-to people relations is pivotal to creating a bright future together."

Kosciuszko Foundation Supports FameLab 2018 Competition in Poland

ameLab is a competition for physicists, engineers,
biotechnologists and other scientists carrying out research
in exact science, natural science, medicine, agriculture or
engineering. Their task is to present their scientific research to the jury
and the audience in the most attractive and understandable manner.
Scientific correctness, the ability to explain complex scientific problems
and charisma are what counts here. Each participant has only 3
minutes to present the chosen topic. In their speech they may use any
props, as long as they can carry them on the stage and operate them
without any help from others. The rules of the competition forbid the
assistance of multimedia aids.

The Polish edition of FameLab, is organized by British Council - Poland and the Copernicus Science Center with the support of the Kosciuszko Foundation. The foundation sponsored a special prize, a 3-month scholarship in the United States (equivalent of 9 thousand dollars). The

scholarship was awarded to Paulina Jedrak. The final was held at the Copernicus Science Center in Warsaw on May 19th 2018.

Paulina Jedrak is a Ph.D. student at the University of Gdańsk where she is working on molecular mechanisms underlying mitochondrial defects in Huntington disease. Since the beginning of her scientific career, she have been highly interested in neuroscience with the emphasis on neurodegeneration. In parallel to the laboratory work, she is also enthusiastic about the popularization of science to a wide audience.

During the FameLab final round, she was talking about the aging of humans and the role of the specific DNA fragments called telomeres in this process. Despite the lack of protein coding information, telomeres are essential for our cells because they protect the DNA against shortening after cell cycle. Some of the cells for instance, a cancer cell lines, have an ability to grow without limits due to the presence of telomerase, the enzyme responsible for the telomeres regeneration.

n today's terms, our Founder, Stephan Miezwa, would be considered an entrepreneur. After only 15 years in the US & minimal english, he was able to create the Kosciuszko Foundation. THE TEACHING ENGLISH IN POLAND, LANGUAGE IMMERSION PROGRAM

Since 1991, the Teaching English in Poland program has been attracting American volunteers of various ethnic backgrounds to staff English immersion summer camps in Poland. The primary goals of the TEIP program are to enhance the Polish students' English language conversational skills and to introduce the young people to the culture and traditions of the United States. THE NATIONAL ADVISORY COUNCIL

THE PRO ARTE LEAGUE

Eugenia and Jerzy Jan Piórkowski Fellowship

he life history of Eugenia nee Drongis and Jerzy Jan Piórkowski is very much the history of Poland's rebirth in 1918 and loss of freedom in 1939. It continued in exile, as they were political emigres who would not accept a Communist government.

Both were born in the part of Poland controlled by the Russians. My Mother was born in Wilejka Powiatowa, in Russia, and my Father was born in the Kingdom of Poland, ruled by Russia. My mother's family, the Rodziewicz's and Iwaszkiewicz's had engaged in the Uprisings of the 19th century, and in each generation, there was someone sent into exile in Siberia. On my maternal side, I am the first generation, since 1793, to be born and live my life in freedom. My Father's family lived in Warsaw, where my grandfather was a tailor.

When my mother was a child, "underground" classes conducted in Polish were held in her family home. Despite being orphaned at an early age, she completed the 'duża Matura' (only 5% of women did at the time) and then attended a teacher's seminary and taught in a bilingual government school in Postawy. My Father attended the well-known Szkoła Górskiego (Szkoła Św. Wojciecha) and then went on to study at GSH (Warsaw School of Economics) while also working.

My Parents did not know each other when the war started. She lived in Pinsk, which was occupied by the Soviets, and was working in the

Telecommunications department at the Post Office. Because the Polish military telegraphic system collapsed, messages were sent through the Post Office, and staff had to take an oath binding them to secrecy. She then agitated after the Evening Masses, encouraging people to vote NO in the referendum on incorporation into the Byelorussian Soviet Socialist Republic. Because of this she was arrested and charged with treason. A trial was held in Moscow (in absentia) where she was sentenced to the Tiemnikovsky Lager, an enormous complex of almost forty camps near Penza.

Jerzy Jan Piórkowski was a reserve officer and as such he was called to active duty in the last days of August. He left Warsaw, never to see it again until 1974. His unit retreated to Lithuania, where they were interned near Wilno. When the Germans and Soviets exchanged control of the Baltic States, the officers from the group, were sent from Lithuania to Kozielsk, as the second transport and thus are known as Kozielsk II. The officers who were brought to Kozielsk in July 1940 discovered messages scratched into the walls – listing dates and numbers – with the notation: direction unknown. Therefore, they were aware of the fact that Polish prisoners had been held there earlier. They were removed by the NKVD and not taken to any other camp. They realized that they could not return to Poland ruled by the Communists, nor could they serve in Berling's Army.

Both Jerzy Jan and Eugenia were among the first to join Anders' Army in Tatiszczewo, and met sometime during those early weeks and shortly they fell. Since she was educated, she was assigned to serve as a nurse, and saved his life when he fell ill with Typhus and Meningitis – in Kermine, the "Valley of Death". As an officer, Jerzy Jan had to request permission to marry, which was granted and the ceremony took place on July 3, 1943 in Quizil Ribat, near Al Sulamaniah, in Irag. Instead of flowers there were a couple of small palm-like plants near the tent. Afterwards they continued to serve in the II Corps through Palestine, Egypt and the Italian campaign. When the Italian Campaign ended, the Army was transferred to England. There they confirmed their decision not to return to a Communist Poland, controlled by the Soviet Union, and they applied for a US Visa. It took 8 years, and in the interim, they emigrated to Canada as 'landed emigrants'.

When they came to Canada, they were 45 years old and they didn't speak English with fluency. Getting one's degree recognized there or in the US, when their documents had been destroyed was nigh unto impossible and meant that they were forced into physical labor.

We moved to New York City in June of 1955 – taking the train from Toronto - and I started elementary school. Their expectations were that I would not fail in any way - not easy to fulfill when you don't speak the language. A dizzying year in First Grade.

Jerzy Jan and Eugenia believed in education, and bi or even trilingualism. They always pointed to Maria Skłodowska-Curie as a great hero. They believed that women should get degrees in Sciences or Math. I disappointed them when I chose a different path.

However, their expectations, and particularly Jerzy Jan's stated belief that I could achieve anything a man could – allowed me to develop my own business and become successful in it, in addition to working for a Fortune 200 company. It is also what has encouraged me to conduct my research in a previously unstudied area – the English-speaking witnesses to Katyn.

Their belief in a free Poland and in the need for education is why I decided to honor their memory by funding the Eugenia and Jerzy Jan Piórkowski Fellowship for Post-Doctoral Studies for Women in STEM Studies. It is my hope and belief that this will allow for major discoveries to be made by Polish scientists working in Poland.

As a former Kosciuszko Foundation post-graduate studies awardee, I am particularly pleased to close this circle – by helping the organization that helped me – and help Poland to help the world.

The Carroll Skinner-Skurzynski Scholarship Fund

arroll X Skurzynski or Carroll Skinner as he was referred to on stage was a life long musician and performer. Born in East Baltimore, Maryland in 1934, Mr. Skurzynski began playing music at a young age. By nine, he was playing the accordion. His career was launched at an early age when he began playing in local taverns in his home city. In high school he started his own band and played both the saxophone and accordion. After graduating from the Polytechnic Institute in 1952 and from the Peabody Conservatory with a degree in theory and education in 1960, he was drafted into the military and spent two years playing in the 3rd Army Band at Fort McPherson, Ga. After he moved to Los Angeles and began working full time in music.

In 1960, he joined Frank Sinatra Jr. and for three years toured all over the world but mostly resided in Las Vegas. When he was not on stage, Carroll Skinner was known for his sense of humor and bright personality. After a decade out West, Mr. Skurzynski returned to his home city and began teaching music in the Baltimore County School System. He continued to perform and played piano for the Zim Zemarel Orchestra. Along with several band members, Mr. Skurzynski performed in the movie, Avalon. He eventually retired from teaching but music remained his passion until his death in December of 2002.

The Carroll Skinner- Skurzynski Scholarship Fund established by Patricia Skurzynski, the sister of Carroll Skinner, will be awarded annually to any Polish citizen or a United States citizen of Polish descent for undergraduate, graduate or post-graduate studies in the

fields of music.

Carroll X. Skurzynski, former resident, musician



Carroll X. Skurzynski, a former resident of the area, died on December 16 of complications from cancer. He was 68 years old.

Born in East Baltimore, Skurzynski was a professional musician, known in the business as "Carroll Skinner," and an educator in the Baltimore County School system. His musical career included accompanying Frank Sinatra, Jr. and playing with the Zim Zemarel Orchestra.

Although he moved to Pikesville in later years, he lived in East Baltimore for the first 26 years of his life, and returned frequently, at one point to live in the area for six more years.

He was a member of the National Musicians Union and the Baltimore County School Association.

He is survived by his sister, Patricia Skurzynski. Other relatives, including his parents, Anna and John Skurzynski, and an aunt, Eleanor Clindienst. are deceased.

A Brief History of the National Advisory Council of the Kosciuszko Foundation

The Kosciuszko Foundation Board of Trustees had established the Council as a means of serving in an advisory capacity for the Board. Their duties include, furthering the mission of the Foundation, advising the Trustees about projects and issue as they relate to the Foundation, both in the short and long term, and assisting with the establishment and supervision of local chapters. For several years, the Council's membership was drawn from the local membership ranks of the Foundation. To expand the scope of the Council's activities the Presidents of local KF Chapters were automatically admitted to the Council (ex-officio) for the duration of their term as Chapter Presidents. The Board of Trustees can only appoint new members to the Council upon approval.

KF Chairman Witold Sulimirski and President Joseph Gore appointed Mrs. Mildred H. Tyszka as President Pro Tempore and charged her with the task of re-activating the Council to support the mission and programs of the Foundation and Trustee initiatives, with a special emphasis on fundraising. Mrs. Tyszka's work included structuring, program establishment, fundraising, chapter additions/revivals and new membership appointments. Her successor was Mr. Charles Pydych. An investment banker in New York, who had an interesting beginning with the Foundation. His boss at the bank was an accomplished violinist who invited him to attend her recital, that took place at the KF Headquarters. Mr. Pydych was so impressed with the musical performance and the KF mansion's architecture and artwork that he became involved and still sits on the Council today. Mark Peszko, Esq., took over as Chairperson after Mr. Pydrych.

Mr. Pydych joined by Andre Zlotnicki and several others became founding members of the Philadelphia Chapter in 1995. Andre Zlotnicki helped secure an estate donated by the Toscik family. The donation

was a townhome located on Elfreth's Alley (the oldest inhabited street in the country), and it served as the Philadelphia Chapter headquarters for a period of time. Andre Zlotnicki became a member of the Council in the mid nineteen-nineties and subsequently the Council Chairperson following the advancement of Mr. Peszko to the Board of Trustees.

In the end of 2002, the Council undertook the task of writing By-Laws for the Geographical Chapters and the National Advisory Council, an effort spearheaded by Ms. Helen Mary M. Tyszka, Vice Chairperson of the Council at the time and Christine Kicinski, Chair of the By-Laws Committee. They were approved by the KF Trustees in 2004.

The Council promoted Chapter engagement through separate Chapter Presidents' meetings. Since Presidents have local duties and logistical issues, separate meetings sponsored by the Council were organized to address management, fiscal reporting and membership growth. On one occasion a weekend retreat was held with the Chapter Presidents at the KF in New York, attended by the KF headquarters staff. On other occasions Chapter Presidents met with the Council Chairperson in the morning and with the Council in the afternoon. In the past, Council members and the KF Trustees attended "off-site" meetings in the following localities: Denver, hosted by the Rocky Mountain Chapter, the Houston Space Center, hosted by the Texas Chapter, Buffalo, hosted by the Western New York Chapter, Philadelphia, hosted by the Philadelphia Chapter and in Chicago, hosted by the Chicago Chapter.

The Council took an active role in forming new Chapters and helping to rescue ailing Chapters through coaching new leadership and sharing experiences of other chapters. Most recently the Council and its Chairperson were involved in the formation of the Washington, DC Chapter, reviving the Pittsburgh Chapter and supporting the revival of the Ohio Chapter.

During the tenure of Chairperson Andre Zlotnicki, the Council instituted annual meetings in Washington DC. The purpose of these meetings was to support the nascent DC Chapter and to give Council members the opportunity to attend the Annual DC Gala and the opportunity to meet personally with the KF Presidents and the KF Chairmen of the Board.

The National Advisory Council has several standing committees such as Education, Program Exchange, Membership and By-Laws. Each committee attracts members interested in its range of activities. In the last several years Chairperson Zlotnicki formed an ad-hoc Media Relations & Publicity Committee devoted to exploration of expanding possibilities of the Internet, digitalization, low cost video production, etc. NAC members Dr. Witold Kawecki and Dr. Mary Kay Pieski contributed to the endeavor. The Council has also served as the initial phase of participation for future trustees, for example Helen Mary Tyszka, Mark Peszko, and Dr. Donald Musialko

The Council also cultivates its members, for example Dr. Teresa Wojcik, who received a Jagiellonian University scholarship in 1995 and who is now a tenured professor at Villanova University and a member of the Council's Education Committee.

The National Advisory Council is currently composed of 25 members from throughout the United States. The membership term is for three years with reelection permitted. Prior membership in the Kosciuszko Foundation is required.

Finally, Council members that form a stable, dedicated and generous group of people are serving on committees beyond the duties of the National Advisory Council such as the Debutante Council, Ball Organizing Committee, Pro Arte League and Polish American Teachers Association, contributing significant financial resources to the Foundation every single year.

The 2018-year has been filled with numerous events. The first being our Dingus Day celebration that has become widely recognized in Western New York and around the United States.





All interviews were conducted in English, thereby evaluating the English proficiency of the candidates. Each interview lasted approximately 30 minutes, including Committee discussions prior to and after each session. Following the interviews, the candidates were ranked from the highest score down (10-0). Discussions at the end of each interview created a basis for evaluating the overall excellence taking into consideration the following factors: candidate's qualifications and accomplishments, importance of the project, written proposal, site of acceptance and overall impression of an applicant's presentation. The Committee had an opportunity to review files of all candidates beforehand in order to evaluate the merit of the candidates' research proposals, their clarity and seriousness of purpose, and the persuasiveness of their arguments for conducting research in the United States.


